**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Shannon Marie Tracy** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Shannon Marie Tracy ("Respondent") is licensed as a resident bail bond agent, Arizona license number 923397 which expires on April 30, 2012.
2. Respondent's addresses of record are: 1543 W. Grand Ave., Phoenix, Arizona 85007 (business); c/o Liberty Bail Bonds, 1543 W. Grand Ave., Phoenix, Arizona 85007 (mailing); and 18490 N. 114<sup>th</sup> Lane, Surprise, Arizona 85379 (residence).
3. On March 16, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on April 10, 2011.
