**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Alex Ettore**  
 10 **Corsaro** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the  
 11 serious nature of these allegations, the Director of Insurance for the State of Arizona  
 12 ("Director") finds that the public health, safety and welfare imperatively require emergency  
 13 action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

- 15 1. Alex Ettore Corsaro ("Respondent") is licensed as a resident bail bond agent,  
 16 Arizona license number 928179 which expires on February 29, 2012.
  - 17 2. Respondent's addresses of record are: c/o Accountable Bail Bonds, Inc., 4215  
 18 N. 16<sup>th</sup> St., Unit #8, Phoenix, Arizona 85016 (business); 108 E. Juniper Ave., Gilbert, Arizona  
 19 85234 (mailing and residence).
  - 20 3. On January 26, 2011, the insurer holding Respondent's surety bond notified the  
 21 Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days  
 22 after receipt of the notice.

1 4. On February 2, 2011, the Department notified Respondent that the surety  
2 holding Respondent's bond was cancelling the bond effective February 26, 2011.

3 5. To date, Respondent has failed to replace the cancelled surety bond.

4 6. Therefore, as of February 26, 2011, Respondent has not maintained a bond in  
5 favor of this State executed by a surety insurer authorized to do business in this State.

6 7. The public health, safety and welfare imperatively require emergency action.

7 **CONCLUSIONS OF LAW**

8 1. The Director has jurisdiction.

9 2. Respondent's conduct constitutes a violation of the requirement that each bail  
10 bond agent maintain in force while license a bond in favor of this State executed by a surety  
11 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


12 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §  
13 41-1092.11(B).

14 **ORDER**

16 1. Respondent's bail bond agent license, Arizona license number 928179, is  
17 summarily suspended effective immediately.
