**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Richard Bundrick** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Richard Bundrick ("Respondent") is licensed as a resident bail bond agent, Arizona license number 950195 which expires on October 31, 2012.
2. Respondent's addresses of record are: Accurate Bail Bonds, 43278 W. Neely Dr., Maricopa, Arizona 85238 (business); 4215 N. 16th St., Phoenix, Arizona 85016 (mailing); 43278 W. Neely Dr., Maricopa, Arizona 85238 (residence).
3. On January 27, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days after receipt of the notice.
