The Arizona Department of Insurance (the "Department") alleges that **Michael William James Phelps** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Michael William James Phelps ("Respondent") is licensed as a resident bail bond agent, Arizona license number 908200 which expires on July 31, 2011.

2. Respondent's addresses of record are: Libra Bonding Co., 5630 Highway 95, #2, Fort Mohave, Arizona 86426 (business); P.O. Box 9352, Ft. Mohave, Arizona 86426 (mailing); and 9755 Arizona Dr., Mohave Valley, Arizona 86440 (residence).

3. On December 22, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on January 15, 2009.
