The State of Arizona Department of Insurance ("Department") has received evidence that Get Out Bail Bonds, LLC, dba: Get Out of Jail Bail Bonds, We Pick You Up Bail Bonds, 1 Call Collect Bail Bonds, 1 Call Us First Bail Bonds, 1 Collect Calls Now Bail Bonds, 1 I'll Pick You Up Bail Bonds, 1 We Pick You Up Bail Bonds, and 1 We Take Collect Calls Bail Bonds ("Get Out Bail Bonds, LLC") and Kristin Marie Roossin ("Respondents") have violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondents wish to resolve this matter without the commencement of formal proceedings, and admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Get Out Bail Bonds, LLC ("Get Out") is, and was at all times material, licensed as a resident bail bond agent, Arizona license number 965627 which expires on May 31, 2014.
- 2. Get Out's addresses of record are: 3232 W. Virginia, Phoenix, Arizona 85009 (business) and 530 E. McDowell Rd., #107-267, Phoenix, Arizona 85004 (mailing).
- 3. Kristin Marie Roossin ("Roossin") is, as was at all times material, licensed as a resident bail bond agent, Arizona license number 964544 which expires on April 30, 2014. Roossin is the Manager and Designated Responsible Licensed Producer for Get Out.
- 4. Roossin's addresses of record are: 139 W. Mohave, Phoenix, Arizona 85003 (business and mailing) and 8863 E. Ann Way, Scottsdale, Arizona 85260 (residence).

Aguirre Complaint

5. On February 17, 2011, Rosa Aguirre ("Aguirre") filed a complaint with the Department against Get Out. On June 12, 2010, Aguirre arranged with Get Out to post a \$5,600 bond for her brother, David Aguirre ("Aguirre bond"). Aguirre securitized the Aguirre bond with her 2001 Ford Escape. On January 28, 2011, the court exonerated the Aguirre bond. To date, Get Out has failed to return Aguirre's collateral.

Hughes Complaint

6. On January 24, 2011, Malia Hughes ("Hughes") filed a complaint with the Department against Get Out. On August 28, 2010, Hughes arranged with Get Out to post a \$3,600 bond for Joseph I. Tarin ("Tarin bond"). Hughes securitized the Tarin bond with a laptop computer, two cameras, and an LCD monitor. Two other indemnitors also offered collateral to securitize the Tarin bond: David Barnella pledged a 1979 boat trailer and Mauricio Abao ("Abao") pledged his 2000 Honda Civic.

- 7. On March 17, 2011, the court exonerated the Tarin bond.
- 8. To date, Get Out has failed to return collateral to both Hughes and Abao.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondents' conduct, as alleged above, constitutes a violation of the requirement that any collateral received shall be returned to the person who deposited it with the bail bond agent or any assignee as soon as the obligation, the satisfaction of which was secured by the collateral, is discharged, within the meaning of A.A.C. R20-6-601(E)(4)(b).
- 3. Respondents' conduct, as alleged above, constitutes a violation of any rule, within the meaning of A.R.S. § 20-295(A)(2) as applied to bail bond agents under A.R.S. § 20-340.06.
- 4. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondents' insurance licenses, pursuant to A.R.S. § 20-295(A) and (B) as applied to bail bond agents under A.R.S. § 20-340.06.

ORDER

IT IS HEREBY ORDERED THAT:

- 1. Respondents shall immediately return the Aguirre collateral.
- 2. Respondents shall immediately return the Hughes collateral.
- 3. Respondents shall immediate return the Abao collateral.
- 4. Respondent's licenses are revoked immediately upon entry of this Order.

CONSENT TO ORDER

- 1. Respondents have reviewed the foregoing Findings of Fact, Conclusions of Law and Order.
- 2. Respondents admit the jurisdiction of the Director of Insurance, State of Arizona, and admit the foregoing Findings of Fact and consent to the entry of the foregoing Conclusions of Law and Order.
- 3. Respondents are aware of their right to notice and hearing at which they may be represented by counsel, present evidence and examine witnesses. Respondents irrevocably waive their right to such notice and hearing and to any court appeals relating to this Consent Order.
- 4. Respondents state that no promise of any kind or nature whatsoever, except as expressly contained in this Consent Order, was made to them to induce them to enter into this Consent Order and that they have entered into this Consent Order voluntarily.
- 5. Respondents acknowledge that the acceptance of this Consent Order by the Director is solely to settle this matter against them and does not preclude any other agency, including the Department, officer, or subdivision of this state or this agency from instituting civil or criminal proceedings as may be appropriate now or in the future.
- 6. Respondents acknowledge that this Consent Order is an administrative action that the Department will report to the National Association of Insurance Commissioners (NAIC). Respondents further acknowledge that they must report this administrative action to any and all states in which they hold an insurance license and must disclose this administrative action on any license application.
