CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **William James Muller ("Respondent")** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Respondent is, and was at all material times licensed as an Arizona resident accident/health and life insurance producer, Arizona license number 61254, which expires March 31, 2014.

2. On or about July 26, 2011, the Court filed a Judgment in The Superior Court of The State of Arizona In and For The County of Maricopa, Case No: CR2011-005630-001 DT convicting Respondent of a class 6 undesignated felony for insurance fraud in violation of A.R.S §§ 20-463(A)(1)(a), 20-466.01, 20-466.02, 13-603, 13-604, 13-701, 13-702, 13-703, 13-707, 13-801 13-802, and 13-804,

1 **CONCLUSIONS OF LAW**

2 1. The Director has jurisdiction over this matter.

3 2. Respondent's conduct, as described above, constitutes having been convicted of  
4 a felony within the meaning of A.R.S. §20-295(A)(6).


5 3. Grounds exist for the Director to suspend, revoke, or refuse to renew  
6 Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to  
7 A.R.S. §§20-295(A) and (F).

8 **ORDER**

9 IT IS HEREBY ORDERED:

10 Respondent's license is revoked effective immediately upon entry of this Order.

5           4.       Respondent states that no promise of any kind or nature whatsoever, except as  
6 expressly contained in this Consent Order, was made to him to induce him to enter into this  
7 Consent Order and that he has entered into this Consent Order voluntarily.

8           5.       Respondent acknowledges that the acceptance of this Consent Order by the  
9 Director is solely to settle this matter against him and does not preclude any other agency,  
10 officer, or subdivision of this state including the Department from instituting civil or criminal  
11 proceedings as may be appropriate now or in the future.

12           6.       Respondent acknowledges that this Consent Order is an administrative action  
13 that the Department will report to the National Association of Insurance Commissioners (NAIC)  
14 and that he may have to report this administrative action on any future licensing applications  
15 either to the Department or other states' Departments of Insurance.
