ORDER GRANTING CONTINUANCE

Respondent.

On April 20, 2012, Respondent filed a Motion to Continue ("Motion") for the reason that his daughter will be in the hospital undergoing stem cell replacement therapy and Respondent requests that the matter be continued for 90 days. On April 25, 2012, the Arizona Department of Insurance filed a Response to the Motion wherein it objected to continuance of the hearing because the hearing had been previously continued from February 21, 2012, for 90 days due to Respondent's daughter's medical condition. The Department asserted that Respondent never qualified for a bail bond agent license but was granted one based on Respondent's failure to disclose a disqualifying conviction.

While the Administrative Law Judge is sympathetic to Respondent's situation, this matter has already been continued for 90 days and cannot be continued for an extended period of time such as another 90 days. However, the Administrative Law Judge finds that good cause has been presented to continue the hearing currently set for May 3, 2012, but that there will be no further continuances granted based upon Respondent's daughter's condition. Respondent is to be prepared to proceed on the hearing date set forth below and, if Respondent wishes to appear telephonically, Respondent is to file a motion in a timely manner as emergency motions or motions that are filed late will not be entertained by this Tribunal.
