The State of Arizona Department of Insurance ("Department") has received evidence that **Barbara Jean Markley-Ver Woert** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Barbara Jean Markley-Ver Woert ("Respondent") is, and was at all material times licensed as a resident travel producer (limited), Arizona license number 982489, which expires February 28, 2014.
2. Respondent's mailing, business and residence addresses of record with the Department are: 3144 N. 7th Ave., Phoenix, Arizona 85013 (business); 2607 N. 197th Ave., Buckeye, Arizona 85396 (mailing and residence).
3. On or about December 21, 2010, the Department issued to Respondent an insurance license as a resident travel producer (limited), Arizona license number 982489.
4. On May 11, 2011, the Department notified Respondent by mail at her mailing/residence address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before June 8, 2011.


