**CONSENT ORDER**

**Respondents.**

The State of Arizona Department of Insurance ("Department") has alleged that **Kenneth Russell Chambers** and **National Bail Bond, LLC** ("Respondents") violated provisions of Title 20, Arizona Revised Statutes. Respondents wish to resolve this matter without the commencement of formal proceedings, admit the following Findings of Fact are true, and consent to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Kenneth Russell Chambers ("Chambers") is licensed as a resident bail bond agent, Arizona license number 990474, which expires on December 31, 2014.
2. Chambers' addresses of record are: 16549 N. 91<sup>st</sup> Dr., Peoria, Arizona 85382 (business and residence) and P.O. Box 6191, Peoria, Arizona 85385 (mailing).
3. National Bail Bond, LLC ("National") is an Arizona corporation licensed as a resident bail bond agent, Arizona license number 995176, which expires on July 31, 2015.
4. National's addresses of record are: 330 E. Thomas Rd., Phoenix, Arizona 85012 (business) and P.O. Box 6191, Peoria, Arizona 85385 (mailing).
5. Until April 12, 2012, Chambers was the sole Member and Manager of National.
6. Chambers is National's Designated Responsible Licensed Producer.


