CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Judy Anne Ochoa** ("Respondent") violated Arizona Revised Statutes ("A.R.S.") §20-295(A)(2), specifically by not participating in providing information to the Department, based upon a subpoena issued by the Director of Department, that was properly served upon her. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

## **FINDINGS OF FACT**

- 1. Respondent is, and was at all material times licensed as an Arizona resident casualty and property insurance producer, Arizona license number 941886, which expires on January 31, 2013.
- 2. On or about March 28, 2012, the Department received a referral from the National Insurance Crime Bureau (NICB) alleging that Respondent inflated her claim to Traveler's Insurance Company with a date of loss of April 20, 2011 ("Traveler's claim number HGX3932").

- 3. On May 9, 2012, the Department sent to Respondent via US Certified Mail a subpoena requiring her to appear before the Department at 10:00 A.M. on May 29, 2012 to provide testimony in the matter of Traveler's claim number HGX3932.
- 4. On May 29, 2012, Respondent appeared at the Department with her attorney, Kirk Smith, and provided a letter (attached) stating that she would not participate, citing constitutional rights.

## **CONCLUSIONS OF LAW**

- 1. The Director has jurisdiction over this matter.
- 2. Respondent's conduct as described above constitutes a violation of A.R.S. §20-295(A)(2), specifically because Respondent did not participate in providing information to the Department on May 29, 2012, based upon the subpoena, that the Department sent to Respondent on May 9, 2012 via certified mail.
- 3. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to A.R.S. §\$20-295(A) and (F), based upon Respondent's violation of A.R.S. §20-295(A)(2), specifically because Respondent did not participate in providing information to the Department on May 29, 2012, based upon the subpoena, that the Department sent to Respondent on May 9, 2012 via certified mail.

1. Respondent's license is revoked effective immediately upon entry of this Order.

officer, or subdivision of this state including the Department from instituting civil or criminal
proceedings as may be appropriate now or in the future.
6. Respondent acknowledges that this Consent Order is an administrative action
that the Department will report to the National Association of Insurance Commissioners (NAIC)
and that she may have to report this administrative action on any future licensing applications
either to the Department or other states' Departments of Insurance.
