**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Arizona Bonding**
 10 **Company, LLC** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In
 11 light of the serious nature of these allegations, the Director of Insurance for the State of
 12 Arizona ("Director") finds that the public health, safety and welfare imperatively require
 13 emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

14
 15 1. Arizona Bonding Company, LLC ("Respondent") is licensed as a resident bail
 16 bond agent, Arizona license number 984837, which expires on February 28, 2015.

17 2. Respondent's addresses of record are: 1106 N. Gilbert Rd., Ste. 2, Mesa,
 18 Arizona 85203 (business); and P.O. Box 52682, Mesa, Arizona 85208 (mailing).

19 3. On July 20, 2011, the insurer holding Respondent's surety bond notified the
 20 Department that Respondent's bail agent bond was to be cancelled, effective on or about
 21 August 22, 2011.

22 4. On August 8, 2011, the Department notified Respondent that the surety holding
 23 Respondent's bond was cancelling the bond effective August 22, 2011.

1 5. To date, Respondent has failed to replace the cancelled surety bond.

2 6. Therefore, as of August 22, 2011, Respondent has not maintained a bond in
3 favor of this State executed by a surety insurer authorized to do business in this State.

4 7. The public health, safety and welfare imperatively require emergency action.

5 **CONCLUSIONS OF LAW**

6 1. The Director has jurisdiction.

7 2. Respondent's conduct constitutes a violation of the requirement that each bail
8 bond agent maintain in force while license a bond in favor of this State executed by a surety
9 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


10 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
11 41-1092.11(B).

12 **ORDER**

13 IT IS HEREBY ORDERED THAT:

14 1. Respondent's bail bond agent license, Arizona license number 984837, is
15 summarily suspended effective immediately.


