FINDINGS OF FACT

- 1. Blaze Bail Bonds of Arizona, Inc. ("Respondent") is licensed as a resident bail bond agent, Arizona license number 932950, which expires on November 30, 2012¹.
- Respondent's addresses of record are: 3012 3014 N. 16th Street. Phoenix. 2. Arizona 85016 (business); and 227 New Brunswick Ave., Perth Amboy, New Jersey 08861 (mailing).
- 3. On March 28, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty days from receipt of the cancellation notice.
- On April 3, 2012 and April 12, 2012, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective April 28, 2012.
- 5. Therefore, as of April 28, 2012, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

The Arizona Corporation Commission administratively dissolved Blaze Bail Bonds of Arizona, Inc. on August 28, 2009 for failure to file its Annual Report.

- 6. On July 31, 2012, the Arizona Department of Insurance ("Department") issued an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Blaze Bail Bonds of Arizona, Inc. (Arizona License # 932950); Docket No. 12A-080-INS.
- 6. On or about August 9, 2012, Respondent submitted a Letter of Clearance Request surrendering its Arizona License, #932950.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. On the written request of a person who is licensed, the Director may accept the voluntary surrender of the person's authority to transact one or more lines of insurance or of the person's entire license, pursuant to A.R.S. § 20-289(F).
- 3. A person who surrenders an authority or a license shall not reapply for the same authority or license for at least one year after the date of the surrender, pursuant to A.R.S. § 20-289(F).

<u>ORDER</u>

IT IS HEREBY ORDERED THAT:

- 1. The Department hereby reactivates Respondent's bail bond agent license.
- 2. Respondent's surrender of its Arizona license, # 932950, is accepted effective August 9, 2012.
