## **FINDINGS OF FACT**

- 1. Freebird Bail Bonds, LLC ("Respondent") is licensed as a resident bail bond agent, Arizona license number 989676, which expires on April 30, 2015.
- 2. Respondent's address of record is: 2217 S. 3<sup>rd</sup> Dr., Phoenix, Arizona 85003 (business and mailing).
- 3. On March 19, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty days after receipt of the cancellation notice.
- 4. Therefore, as of April 19, 2012, Respondent had not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
- 5. On July 31, 2012, the Arizona Department of Insurance ("Department') issued an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Freebird Bail Bonds, LLC (Arizona License # 989676); Docket No. 12A-083-INS.
- 6. On or about August 6, 2012, Respondent provided evidence to the Department that it had procured a new bond.
