**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Daniel Walter Ipsen** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Daniel Walter Ipsen ("Respondent") is licensed as a resident bail bond agent, Arizona license number 49364, which expires on June 30, 2014.
2. Respondent's addresses of record are: c/o Alliance Bail Bonds, 12 N. Center St., Mesa, Arizona 85201 (business and mailing); 11809 W. Donald Dr., Sun City, Arizona 85373 (residence).
3. On July 25, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the date of the notice.
