**ORDER REINSTATING  
BAIL BOND AGENT LINE  
OF AUTHORITY AND  
ACCEPTING SURRENDER OF  
ENTIRE LICENSE**

**FINDINGS OF FACT**

1. Vanessa Lynne Lager ("Respondent") is licensed as a resident accident/health and life producer and bail bond agent, Arizona license number 858765, which expires on July 31, 2013.

2. Respondent's addresses of record are: 1211 W. Silverlake Rd., Tucson, Arizona 85713 (business and mailing); 3595 W. Avenida Del Mar, Tucson, Arizona 85746 (residence).

3. On May 17, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty days after receipt of the cancellation notice.

4. On May 23, 2012, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective June 17, 2012.

5. Therefore, as of June 17, 2012, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

6. On July 31, 2012, the Arizona Department of Insurance ("Department") issued an Order Summarily Suspending Bail Bond Agent Line of Authority and Notice of Opportunity

3 6. On or about July 30, 2012, Respondent submitted a Letter of Clearance Request  
4 surrendering her entire Arizona License, #858765.

5 **CONCLUSIONS OF LAW**

6 1. The Director has jurisdiction.

7 2. On the written request of a person who is licensed, the Director may accept the  
8 voluntary surrender of the person's authority to transact one or more lines of insurance or of  
9 the person's entire license, pursuant to A.R.S. § 20-289(F).

10 3. A person who surrenders an authority or a license shall not reapply for the same  
11 authority or license for at least one year after the date of the surrender, pursuant to A.R.S. §  
12 20-289(F).

13 **ORDER**


14 IT IS HEREBY ORDERED THAT:

15 1. The Department hereby reactivates Respondent's bail bond agent line of  
16 authority.

17 2. Respondent's surrender of her entire Arizona license (including the bail bond  
18 agent line of authority), # 858765, is accepted effective on July 30, 2012.

19 3. Respondent may not apply for a license for at least one year after the effective  
20 date of the surrender.

**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LINE OF  
AUTHORITY AND NOTICE OF  
OPPORTUNITY FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Vanessa Lynne Lager** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Vanessa Lynne Lager ("Respondent") is licensed as a resident accident/health and life producer and bail bond agent, Arizona license number 858765, which expires on July 31, 2013.
