**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Marie Louise**
10 **Witherspoon** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light
11 of the serious nature of these allegations, the Director of Insurance for the State of Arizona
12 ("Director") finds that the public health, safety and welfare imperatively require emergency
13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 15 1. Marie Louise Witherspoon ("Respondent") is licensed as a resident bail bond
 16 agent, Arizona license number 4210, which expires on October 31, 2014.
- 17 2. Respondent's addresses of record are: 3714 W. Berridge Lane, Phoenix,
 18 Arizona 85019 (business and mailing); 5547 W. Sunnyslope Lane, Glendale, Arizona 85302
 19 (residence).
- 20 3. On March 19, 2012, the insurer holding Respondent's surety bond notified the
 21 Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the
 22 date of the notice.
