CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Robert Michael Flynn ("Respondent") violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent is, and was at all material times licensed as an Arizona resident accident/health, life, variable life/variable annuities, property and casualty insurance producer, Arizona license number 937072, which expires on November 30, 2012.

2. Respondent was at all material times contracted with Country Financial Insurance Group which includes Country Mutual Insurance Company ("Country Mutual") to transact insurance on its behalf in Arizona.

3. Between December 2011 and March 2012, Respondent created and submitted 13 fictitious automobile insurance policy applications to Country Mutual to meet his monthly benchmarks.

CONCLUSIONS OF LAW

2 1. The Director has jurisdiction over this matter.

3 2. Respondent's conduct, as described above, constitutes using fraudulent,
4 coercive or dishonest practices, or demonstrating incompetence, untrustworthiness or financial
5 irresponsibility in the conduct of business in this state or elsewhere, within the meaning of
6 A.R.S. §20-295(A)(8).

7 3. Respondent's conduct, as described above, constitutes intentionally
8 misrepresenting the terms of an actual or proposed insurance contract or application for
9 insurance, within the meaning of A.R.S. § 20-295(A)(5).


10 4. Grounds exist for the Director to suspend, revoke, or refuse to renew
11 Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to
12 A.R.S. §§20-295(A) and (F).

13 **ORDER**

14 IT IS HEREBY ORDERED THAT:

15 Respondent's license is revoked effective immediately upon entry of this Order.
