

The Arizona Department of Insurance ("Department") has received evidence that **Arizona Asset Management and Recovery, Inc. dba Better Bail Bonds and Lisa Marie Burns ("Respondents")** have unlawfully transacted immigration bonds in the State of Arizona. Accordingly, the Acting Director of Insurance of the State of Arizona (the "Acting Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. § 20-292.

FINDINGS OF FACT

1. Arizona Asset Management and Recovery, Inc. dba Better Bail Bonds ("AZ Asset Management") is licensed with the Department as a resident bail bond agent, Arizona license number 957364, which expires on December 31, 2013.

2. AZ Asset Management does not hold a license in Arizona as a property and casualty producer.

3. Lisa Marie Burns ("Burns") is, and was at all times material, licensed with the Department as a resident bail bond agent, Arizona license number 955041, which expires on September 30, 2013.

2 IT IS THEREFORE ORDERED:

3 1. AZ Asset Management shall immediately cease and desist transacting
4 immigration bonds.

5 2. This Order shall become effective immediately and shall remain in full force
6 and effect until otherwise stayed, modified, vacated or set aside.


