The State of Arizona Department of Insurance ("Department") has received evidence that **Carolyn Kim Writght-Ruppert** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Carolyn Kim Wright-Ruppert ("Respondent") is, and was at all material times licensed as a resident accident/health, life and variable life/variable annuities insurance producer, Arizona license number 987613, which expires January 31, 2015.
2. Respondent's mailing, business and residence addresses of record with the Department are: c/o Edward Jones, 3654 N. Power Rd., Suite 169, Mesa, Arizona 85215 (business and mailing); 10265 E. Dolphin Ave., Mesa, Arizona 85208 (residence).
3. On or about March 15, 2011, the Department issued to Respondent an insurance license as an accident/health, life and variable life/variable annuities producer, Arizona license number 987613.
4. On October 31, 2011, the Department notified Respondent by mail at her business/ mailing address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before November 30, 2011.





1           6.       Respondent acknowledges that this Consent Order is an administrative action  
2 that the Department will report to the National Association of Insurance Commissioners  
3 (NAIC). Respondent further acknowledges that she must report this administrative action to  
4 any and all states in which she holds an insurance license and must disclose this  
5 administrative action on any license application.
