CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Michael Devon Jamison ("Respondent")** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Respondent is, and was at all material times, licensed as an Arizona resident accident/health, life, casualty, and property insurance producer, Arizona license number 988889, which expires on December 31, 2014.

2. Respondent's address of record is: 47808 N. 15<sup>th</sup> Lane, New River, Arizona 85087 (business/residence).

3. Respondent was at all material times contracted with Farmers Insurance Company ("Farmers") to transact insurance on its behalf in Arizona.

4. On or about September 28, 2011, Respondent submitted a policy application for homeowner's insurance in the name of Thomas Clawson to Farmers.

5. Respondent falsified a receipt when he submitted the policy application.
