**ORDER VACATING ORDER TO CEASE
AND DESIST**

On December 27, 2012, the State of Arizona Department of Insurance ("Department") issued a Cease and Desist Order in the above-captioned matter ("Cease and Desist") (Exhibit A). The Cease and Desist found that the Regulator Bail Bonds, Inc. website, <http://regulatorbailbonds.com>, stated "Regulator Bail Bonds is one of the ONLY companies in Arizona that can help you with your Immigration Bond needs!"¹ without being licensed as a property and casualty insurer in violation of Arizona Revised Statutes ("A.R.S.") § 20-340.01(D).

On January 15, 2013 and February 1, 2013, Respondents provided evidence to the Department that it had removed the reference to immigration bonds on its home page, removed the entire page relating to immigration bond transactions and that it has never written or posted any immigration bonds in Arizona. ORDER TO CEASE
AND DESIST

The Arizona Department of Insurance ("Department") has received evidence that **Regulator Bail Bonds, Inc. and George Myles Andrew Wirtjes ("Respondents")** have unlawfully transacted immigration bonds in the State of Arizona. Accordingly, the Director of Insurance of the State of Arizona (the "Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. § 20-292.

FINDINGS OF FACT

1. Regulator Bail Bonds, Inc. ("Regulator") is licensed with the Department as a resident bail bond agent, Arizona license number 984892, which expires on February 28, 2015.

2. Regulator's address of record is: 2117 S. 48th St., Suite #106, Tempe, Arizona 85282 (business and mailing).

3. Regulator does not hold a license in Arizona as a property and casualty producer.

4. George Myles Andrew Wirtjes ("Wirtjes") is, and was at all times material, licensed with the Department as a resident bail bond agent, Arizona license number 985320, which expires on March 31, 2014.

ORDER

IT IS THEREFORE ORDERED:

- 1. Regulator shall immediately cease and desist transacting immigration bonds.
- 2. This Order shall become effective immediately and shall remain in full force and effect until otherwise stayed, modified, vacated or set aside.


NOTICE OF OPPORTUNITY FOR HEARING

Pursuant to Title 20 of the Arizona Revised Statutes, Respondent is hereby notified that it may request a hearing pursuant to A.R.S. § 20-161 to contest the order to cease and desist. Such a request must be in writing and received at the following address within thirty (30) days from the date hereof:

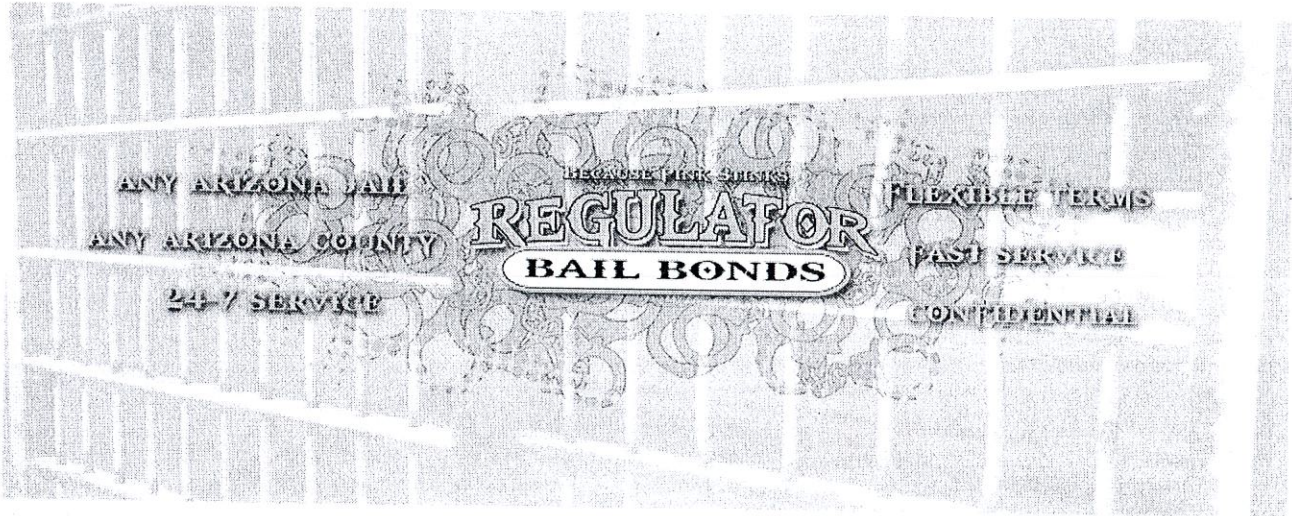
