CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Paul Stewart Parker** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Paul Stewart Parker ("Respondent") was licensed with the Department as a resident life insurance producer, Arizona license number 77756 which expired on October 31, 2012.
2. Respondent's addresses of record are: 72 West Patton, St. David, Arizona 85630 (business), P.O. Box 448, St. David, Arizona 85630 (mailing), and 1500 So. Lobos Run, Benson, Arizona 85602 (residence).
3. On or about October 1, 2012, Respondent submitted a license renewal application to the Department ("October 1, 2012 Application").


1 waives his right to such notice and hearing and to any court appeals relating to this Consent

3 4. Respondent states that no promise of any kind or nature whatsoever, except as
4 expressly contained in this Consent Order, was made to him to induce him to enter into this
5 Consent Order and that he has entered into this Consent Order voluntarily.

6 5. Respondent acknowledges that the acceptance of this Consent Order by the
7 Director is solely to settle this matter against him and does not preclude any other agency,
8 officer, or subdivision of this state from instituting proceedings as may be appropriate now or
9 in the future.

10 6. Respondent acknowledges that this Consent Order is an administrative action
11 that the Department will report to the National Association of Insurance Commissioners
12 (NAIC). Respondent further acknowledges that he must report this administrative action to
13 any and all states in which he holds an insurance license and must disclose this administrative
14 action on any license application.
