**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **John Andrew Hedges** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. John Andrew Hedges ("Respondent") is licensed as a resident bail bond agent, Arizona license number 960698, which expires on April 30, 2013.
2. Respondent's addresses of record are: 657 W. University Dr., Mesa, Arizona 85201 (business and mailing); 14424 S. 41st Way, Phoenix, Arizona 85044 (residence).
3. On December 28, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective December 21, 2012.
4. On January 14, 2013, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective January 28, 2013.

1 **NOTICE OF OPPORTUNITY FOR HEARING**

2 Pursuant to Title 20 of the Arizona Revised Statutes, Respondent is hereby notified
3 that Respondent may request a hearing pursuant to A.R.S. § 20-161 to contest the summary
