ORDER SUMMARILY SUSPENDING LICENSE NOTIFICATION OF RIGHTS

Respondents.

The State of Arizona Department of Insurance ("Department") has received evidence that George Myles Andrew Wirtjes and Regulator Bail Bonds, Inc.

("Respondents") violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. § 41-1092.11(B).

FINDINGS OF FACT

- 1. George Myles Andrew Wirtjes ("Wirtjes") is, and was at all material times, licensed as an Arizona resident bail bond agent, Arizona license number 985320, which expires on March 31, 2014.
- Wirtjes' address of record with the Department is: 2117 S. 48th Street, Suite 106,
 Tempe, Arizona 85282 (business, mailing and residence).

- 3. Regulator Bail Bonds, Inc. ("Regulator") is, and was at all material times, licensed as an Arizona resident bail bond agent, Arizona license number 984892, which expires on February 28, 2015¹.
- 4. Regulator's address of record with the Department is: 2117 S. 48th Street, Suite #106, Tempe, Arizona 85282 (business and mailing).
- Wirtjes is the President and Designated Responsible Licensed Producer
 ("DRLP") for Regulator.

Failure to Return Collateral

- 6. On or about December 9, 2011, Respondents received \$1,000.00 as cash collateral toward a \$10,000.00 surety bond from Lisa Collins. Respondents posted the bond. On July 10, 2013, the court exonerated the \$10,000.00 bond. To date, Respondents have failed to return the \$1,000.00 cash collateral to Lisa Collins.
- 7. On or about December 26, 2012, Respondents received \$10,000.00 as cash collateral to secure a \$10,000.00 surety bond from Dorothy Benson. Respondents posted the bond. On March 29, 2013, the court exonerated the \$10,000.00 bond. To date, Respondents have failed to return the \$10,000.00 cash collateral to Dorothy Benson.

Failure to Maintain a Place of Business

8. As of this date, Regulators has closed its office.

CONCLUSIONS OF LAW

1. The Director has jurisdiction over this matter.

Regulator is not a corporation in good standing with the Arizona Corporation Commission.

- 2. Respondents' conduct, as described above, constitutes improperly withholding monies received in the course of doing insurance business within the meaning of A.R.S. § 20-295(A)(4) as applied to bail bond agents under A.R.S. § 20-340.06.
- 3. Respondents' conduct, as described above, constitutes failure to return collateral received to the person who deposited it with the bail bond agent or any assignee as soon as the obligation, the satisfaction of which was secured by the collateral, is discharged, within the meaning of Arizona Administrative Code ("A.A.C.") R20-6-601(E)(4)(b).
- 4. Respondents' conduct, as described above, constitutes violating any provision of Title 20 or any rule, subpoena or order of the director, within the meaning of A.R.S.§ 20-295(A)(2) as applied to bail bond agents under A.R.S. § 20-340.06.
- 5. Respondents' conduct, as described above, constitutes the failure to have and maintain a place of business in this state that is accessible to the public and where the bail bond agent principally conducts transactions under the agent's license, within the meaning of A.R.S. § 20-340.01(E).
- 6. Respondents' conduct, as described above, constitutes using fraudulent, coercive or dishonest practices, or demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere within the meaning of A.R.S. § 20-295(A)(8) as applied to bail bond agents under A.R.S. § 20-340.06.
- 7. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondents' insurance licenses and/or order restitution pursuant to A.R.S. §§ 20-295(A), (B) and (F).

IT IS HEREBY ORDERED THAT:

- 1. Respondent George Myles Andrew Wirtjes' Arizona license, number 985320, is summarily suspended, effective immediately upon entry of this Order.
- 2. Respondent Regulator Bail Bonds, Inc.'s Arizona license, number 984892, is summarily suspended, effective immediately upon entry of this Order.
- 3. Respondents shall immediately pay restitution to Lisa Collins in the amount of \$1,000.00.
- Respondents shall immediately pay restitution to Dorothy Benson in the amount 4. of \$10,000.00.
 - Respondents are jointly and severally responsible for the payment of restitution. 5. DATED AND EFFECTIVE this 12th day of sententer, 2013.
