CONSENT ORDER

Respondent.

The State of Arizona Department of Insurance ("Department") has received evidence that **Wayne B Finlinson** violated provisions of Title 20, Arizona Revised Statutes.

Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Wayne B Finlinson ("Finlinson" or "Respondent") is, and was at all material times, licensed as an Arizona non-resident accident/health, life, property and casualty insurance producer, Arizona license number 905599, which expires August 31, 2015.

2. Finlinson's address of record is: 971 S. Morningside Dr., St. George, Utah 84790 (business and residence) and P.O. Box 910567, St. George, Utah 84791 (mailing).

3. On or about November 10, 2013, Finlinson forged the signature of Gloria Jean Long ("Mrs. Long") and Louie Silas Long ("Mr. Long") on two individual life insurance policy applications a total of six times to enroll them in two life insurance policies with Occidental Life Insurance Company of North Carolina ("Occidental.")

1 4. Respondent states that no promise of any kind or nature whatsoever, except as
2 expressly contained in this Consent Order, was made to him to induce him to enter into this
3 Consent Order and that he has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the
5 Director is solely to settle this matter against him and does not preclude any other agency,
6 including the Department, officer, or subdivision of this state or this agency from instituting civil
7 or criminal proceedings as may be appropriate now or in the future.

8 6. Respondent acknowledges that this Consent Order is an administrative action
9 that the Department will report to the National Association of Insurance Commissioners
10 (NAIC). Respondent further acknowledges that he must report this administrative action to
11 any and all states in which he holds an insurance license and must disclose this administrative
12 action on any license application.
