Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance ("Department"), the Director finds as follows:

FINDINGS OF FACT

- 1. USAA Direct Life Insurance Company ("Petitioner") is a Nebraska domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective October 6, 1969.
- 2. Petitioner, the non-surviving entity, merged into USAA Life Insurance Company (ULIC), NAIC No. 69663, the surviving entity, a Texas domiciled insurer effective December 31, 2013. ULIC is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- The Insurance Commissioner of Nebraska approved the merger of Petitioner into
 ULIC on August 9, 2013.
