Arizona Revised Statutes (A.R.S.) § 23-961 provides that workers' compensation deposits shall be held by the Director of Insurance as security for fulfillment of the obligations of an insurer under Title 23.

FINDINGS OF FACT

- 1. Mendakota Insurance Company ("Petitioner"), a Minnesota domiciled insurance company, received its certificate of authority to transact property and casualty insurance including workers' compensation in Arizona on February 25, 2004.
- 2. The Arizona Department of Insurance ("Department") presently holds a workers' compensation deposit for the protection of Petitioner's Arizona workers' compensation policyholders and claimants in the amount of \$105,000 pursuant to A.R.S. § 23-961 ("WC Deposit").
- 3. On April 2, 2014, Petitioner requested the termination of its workers' compensation authority in the State of Arizona and requested the release of its workers' compensation deposit.
- 4. On April 3, 2014, the Petitioner's workers' compensation authority was terminated from its certificate of authority.
 - 5. Petitioner has no obligations under any workers' compensation policy of

1	insurance to any policyholders or claimants who are residents of Arizona.
2	6. Petitioner is not the subject of any pending investigation or market conduct
3	examination, and Petitioner does not owe the Department any filings or fees.
4	CONCLUSIONS OF LAW
5	1. The Director has no personal liability for the release of such deposit so made by
6	her in good faith as provided in A.R.S. § 20-588(B).
7	2. Petitioner is entitled to a release of the workers' compensation deposit pursuant
8	to A.R.S. § 20-588(A)(1).
	ORDER
9	THEREFORE, IT IS ORDERED that the workers' compensation deposit in the amount
10	\$105,000 shall be released to Petitioner.
