CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Trent Michael Shenefield** violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Trent Michael Shenefield ("Respondent" or "Shenefield") is, and was at all material times, licensed as an Arizona resident adjuster, Arizona license number 873024.
2. Shenefield's addresses of record are: Republic Western Insurance, 2721 N. Central Ave., Phoenix, Arizona 85004 (business); P.O. Box 24463, Phoenix, Arizona 85074 (mailing); and 1658 W. Cottonwood Ln., Phoenix, Arizona 85045-0806 (residence).
3. On or about April 30, 2014, Respondent timely submitted an Insurance License Renewal Application ("Application") to the Department. Part II, Question C of the Application asks: C. Have you been convicted or found guilty of, have you had a judgment made against you for, or have you admitted to, any of the following that has not been previously disclosed in a written format by you to this agency: 1. A felony of any kind? Respondent answered "Yes" to subpart 1 of Question C and provided materials related to the response.


1 hundred dollars; or impose a civil penalty of not more than two thousand five hundred dollars
2 for each intentional failure or violation, up to an aggregate civil penalty of fifteen thousand
3 dollars, within the meaning of A.R.S. § 20-295(F) as applied to adjusters under A.R.S. § 20-

6 IT IS HEREBY ORDERED THAT:

7 1. Respondent shall pay of civil penalty of \$500.00 for deposit into the State
8 General Fund.

18 Conclusions of Law and Order.


19 3. Respondent is aware of his right to notice and hearing at which he may be
20 represented by counsel, present evidence and examine witnesses. Respondent irrevocably
21 waives his right to such notice and hearing and to any court appeals relating to this Consent
22 Order.

1 4. Respondent states that no promise of any kind or nature whatsoever, except as
2 expressly contained in this Consent Order, was made to him to induce them to enter into this
3 Consent Order and that he has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the
5 Director is solely to settle this matter against him and does not preclude any other agency,
6 including the Department, officer, or subdivision of this state or this agency from instituting civil
7 or criminal proceedings as may be appropriate now or in the future.

8 6. Respondent acknowledges that this Consent Order is an administrative action
9 that the Department will report to the National Association of Insurance Commissioners
10 (NAIC). Respondent further acknowledges that he must report this administrative action to
11 any and all states in which he holds an insurance license and must disclose this administrative
12 action on any license application.


