**FINDINGS OF FACT**

1. Ralph Cooper Randolph ("Respondent") is licensed as a resident bail bond agent, Arizona license number 145356, which expires on July 31, 2016.

2. Respondent's addresses of record are: c/o Randolph Bail Bonds, Inc., 49 S. Mesa Dr., Mesa, Arizona 85210 (business and mailing).

3. On August 31, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the date of the notice.

4. On September 10, 2011, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective October 30, 2011.

5. On August 2, 2012, the Arizona Department of Insurance ("Department") filed an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Randolph, Ralph Cooper (Arizona License # 145356); Docket No. 12A-090-INS.

6. On or about January 29, 2015, Respondent provided evidence to the Department that he had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.


3 2. Respondent's conduct constitutes compliance with the requirement that each bail  
4 bond agent maintain in force while license a bond in favor of this State executed by a surety  
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

6 ORDER

7 IT IS HEREBY ORDERED THAT:

8 1. With the submission of the statutorily required surety bond, the Department  
9 shall reactivate Respondent's Arizona license, number 145356, as of the filing date of this  
10 Order Reinstating Bail Bond Agent License.
