FINDINGS OF FACT

- Respondent, American Financial Security Life Insurance Company is a Missouri 1. domiciled life and disability insurer initially granted authority to transact life and disability insurance business in Arizona on September 16, 1982.
- On January 25, 1993, the Director issued an order suspending the certificate of 2. authority of Respondent based upon Respondent's failure to meet the requirements for the authority originally granted to it within the meaning of Arizona Revised Statutes ("A.R.S.") §20-219(2).
- Respondent filed an application for reinstatement on December 14, 2010 and 3. has corrected all deficiencies and meets the requirements for the authority to transact insurance within the meaning of A.R.S. Title 20.
