

**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE AND
NOTICE OF OPPORTUNITY FOR
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Timothy Bryant Canfield** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Timothy Bryant Canfield ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1028837, which expires on July 31, 2016.
2. Respondent's addresses of record are: c/o 2nd Chance Bail Bonds, 41610 N. Hudson Trail, Anthem, Arizona 85086 (business) and 1646 W. Culver St., Phoenix, Arizona 85007 (mailing).
3. On August 1, 2014, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective September 3, 2014 or 30 days after the Department's receipt of the notice (whichever was later).

1 4. On August 7, 2014, the Department notified Respondent that the surety holding
2 Respondent's bond was cancelling the bond effective September 4, 2014.

3 5. To date, Respondent has failed to replace the cancelled surety bond.

4 6. Therefore, as of or about September 4, 2014, Respondent has not maintained a
5 bond in favor of this State executed by a surety insurer authorized to do business in this State.

6 7. The public health, safety and welfare imperatively require emergency action.

7 **CONCLUSIONS OF LAW**

8 1. The Director has jurisdiction.

9 2. Respondent's conduct constitutes a violation of the requirement that each bail
10 bond agent maintain in force while license a bond in favor of this State executed by a surety
11 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

12 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
13 41-1092.11(B).

14 **ORDER**

15 IT IS HEREBY ORDERED THAT:

16 1. Respondent's bail bond agent license, Arizona license number 1028837, is
17 summarily suspended effective immediately.
