**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE AND
NOTICE OF OPPORTUNITY FOR
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Stephanie Leon Ordaz** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Stephanie Leon Ordaz ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1060196, which expires on February 28, 2017.
2. Respondent's addresses of record are: c/o 10002 N. 7th Street, #1137, Phoenix, Arizona 85020 (business and mailing).
3. On August 26, 2013, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective October 1, 2013.
4. On October 16, 2013, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective September 29, 2013.
5. To date, Respondent has failed to replace the cancelled surety bond.
