**ORDER REINSTATING
BAIL BOND AGENT LICENSE**

FINDINGS OF FACT

1. Tranisha Kay Robinette ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1091011, which expires on December 31, 2017.

2. Respondent's addresses of record are: c/o Dignity Bail Bonds, LLC, 1 E. Washington St., #500, Phoenix, Arizona 85004 (business and mailing).

3. On October 22, 2014, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective December 1, 2014.

4. On October 29, 2014, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective November 14, 2014.

5. On August 5, 2015, the Department filed an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Robinette, Tranisha Kay (Arizona License # 1091011); Docket No. 15A-094-INS.

6. On or about September 21, 2015, Respondent provided evidence to the Department that she had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.

3 2. Respondent's conduct constitutes compliance with the requirement that each bail
4 bond agent maintain in force while license a bond in favor of this State executed by a surety
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

6 ORDER

7 IT IS HEREBY ORDERED THAT:

8 1. With the submission of the statutorily required surety bond, the Department
9 shall reactivate Respondent's bail bond agent license, number 1091011, as of the filing date of
10 this Order Reinstating Bail Bond Agent License.
