CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes compliance with the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

ORDER

1. With the submission of the statutorily required surety bond, the Department shall reactivate Respondent's bail bond agent line of authority under Arizona license, number 898005, as of the filing date of this Order Reinstating Bail Bond Agent Line of Authority.
