**ORDER REINSTATING  
BAIL BOND AGENT LINE OF  
AUTHORITY**

**FINDINGS OF FACT**

1. Leslie Pierre Sparks ("Respondent") is licensed as a resident accident/health, life, variable life/variable annuities, property and casualty insurance producer and bail bond agent, Arizona license number 898005, which expires on September 30, 2018.

2. Respondent's addresses of record are: 15336 W. Turney Ave., Goodyear, Arizona 85395 (business and mailing).

3. On February 16, 2015, the insurer holding Respondent's surety bond notified the Arizona Department of Insurance ("Department") that Respondent's bail agent bond was to be cancelled, effective April 17, 2015.

4. On February 25, 2015, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective April 17, 2015.

5. On August 5, 2015, the Department filed an Order Summarily Suspending Bail Bond Agent Line of Authority and Notice of Opportunity for Hearing In the Matter of Sparks, Leslie Pierre (Arizona License # 898005); Docket No. 15A-095-INS.

6. On or about August 12, 2015, Respondent provided evidence to the Department that he had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.


3 2. Respondent's conduct constitutes compliance with the requirement that each bail  
4 bond agent maintain in force while license a bond in favor of this State executed by a surety  
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

6 ORDER

7 IT IS HEREBY ORDERED THAT:

8 1. With the submission of the statutorily required surety bond, the Department  
9 shall reactivate Respondent's bail bond agent line of authority under Arizona license, number  
10 898005, as of the filing date of this Order Reinstating Bail Bond Agent Line of Authority.


