ORDER REINSTATING
BAIL BOND AGENT LICENSE

FINDINGS OF FACT

1. Raymond Neal Ogden ("Respondent") is licensed as a resident bail bond agent, Arizona license number 896621, which expires on December 31, 2018.

2. Respondent's address of record is: 3610 N. Penny Lane, Cottonwood, AZ 86326 (business and mailing).

3. On August 31, 2015, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective October 2, 2015.

4. On September 1, 2015, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective October 2, 2015.

5. On February 17, 2016, the Arizona Department of Insurance ("Department") filed an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Ogden, Raymond Neal (Arizona License # 896621); Docket No. 16A-013-INS.

6. On or about April 28, 2016, Respondent provided evidence to the Department that he had procured a new bond with an effective date of March 11, 2016.

1 CONCLUSIONS OF LAW

2 1. The Interim Director has jurisdiction.


3 2. Respondent's conduct constitutes compliance with the requirement that each bail
4 bond agent maintain in force while licensed a bond in favor of this State executed by a surety
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

6 ORDER

7 IT IS HEREBY ORDERED THAT:

8 1. With the submission of the statutorily required surety bond, the Department
9 shall reactivate Respondent's Arizona license, number 896621, as of the filing date of this
10 Order Reinstating Bail Bond Agent License.
