ORDER SUMMARILY SUSPENDING BAIL BOND AGENT LICENSE AND NOTICE OF OPPORTUNITY FOR HEARING

The Arizona Department of Insurance (the "Department") alleges that **Raquel Marie Ramirez** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Interim Director of Insurance for the State of Arizona ("Interim Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- Raquel Marie Ramirez ("Respondent") is licensed as a resident bail bond agent,
 Arizona license number 1082392, which expires on February 28, 2018.
- Respondent's address of record is: c/o Bailzona Bail Bonds, 8831 E. Main St.,
 Ste 1, Mesa, AZ 85207 (business and mailing).
- 3. On October 29, 2015, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective immediately upon the Department's receipt of the cancellation notice.
- 4. On November 9, 2015, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective November 29, 2015.

To date, Respondent has failed to replace the cancelled surety bond.
