The State of Arizona Department of Insurance ("Department") has received evidence that **RONALD RASSWEILER HARDERS** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

#### FINDINGS OF FACT

- 1. Ronald Rassweiler Harders ("Respondent") is and was at all material times licensed as a credit, accident/health, life and var. life/var. annuities producer, Arizona license number 1118929, which expires August 31, 2019.
- 2. Respondent's addresses of record with the Department are: 6606 S. 5<sup>th</sup> Way, Phoenix, AZ 85042 and (business and residence) and P.O. Box 90290, Phoenix, AZ 85016 (mailing).
- 3. On or about August 10, 2015, the Department issued to Respondent an insurance license as a credit, accident/health, life and var. life/var. annuities producer, Arizona license number 1115322.
- 4. On October 26, 2015, the Department notified Respondent by mail at his address of record that his fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set

of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before November 22, 2015. Respondent did not reply to the Department's request.

- 5. On November 25, 2015, the Department notified Respondent a second time by mail at his address of record that his fingerprints had been returned by DPS as illegible and that the Department was about to initiate an administrative action against his license for failure to comply with the fingerprint requirement. The Department requested a response by December 24, 2015.
- 6. To date, Respondent has not submitted a full set of fingerprints to the Department.

#### CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondent's conduct as described above constitutes the violation of the requirement that an applicant submit a full set of fingerprints to the Department within the meaning of A.R.S. § 20-285(E)(2).
- 3. Respondent's conduct as described above constitutes providing incomplete information in the license application within the meaning of A.R.S. § 20-295(A)(1).
- 4. Respondent's conduct as described above constitutes the violation of any provision of A.R.S. Title 20 or any rule, subpoena or order of the director within the meaning of A.R.S.§20-295(A)(2).
- 5. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to A.R.S. §§20-295(A) and (F).

#### **ORDER**

## IT IS HEREBY ORDERED THAT:

1. Respondent may surrender her insurance producer license, Arizona license number **1118929**.

2. The hearing, Docket #16A-021-INS, scheduled for June 29, 2016, at 1:00 p.m. is vacated.
