NOTIFICATION OF RIGHTS

Pursuant to Arizona Revised Statutes ("A.R.S.") § 41-1092.09, Respondent may request a rehearing with respect to this order by filing a written motion with the Interim Director of the Department of Insurance within 30 days of the date of this Order, setting forth the basis for relief under A.A.C. R20-6-114(B). Pursuant to A.R.S. § 41-1092.09, it is not necessary to request a rehearing before filing an appeal to Superior Court.

FINDINGS OF FACT

- 1. On August 4, 2016, the Arizona Department of Insurance ("Department") issued a Notice of Hearing setting the above-captioned matter for hearing on September 27, 2016.
- 2. The matter was continued and rescheduled to be convened at 8:00 a.m. on January 17, 2017.
- 3. No representative for Respondent Jessica Marie Blatzheim appeared at the scheduled time and the matter was convened in her absence at about 8:30 a.m. on January 17, 2017.
- 4. On August 13, 2015, Respondent submitted to the Department an application for a license. With the application, Respondent included a copy of her fingerprints.
- 5. The Department issued to Respondent License No. 1122829, which is scheduled to expire on February 28, 2019.
- 6. The Department forwarded Respondent's fingerprints the Arizona Department of Public Safety ("DPS") for a criminal records background check. Respondent's fingerprints were not of sufficient quality for use in conducting the background check.
- 7. An applicant who submits illegible fingerprints is considered by the Department to have submitted an incomplete application.

- 8. In a letter dated December 21, 2015, the Department informed Respondent that on or before January 22, 2016, she was required to submit to the Department a replacement set of fingerprints.
- The Department did not receive from Respondent any response to its December
 21, 2015 letter.
- 10. In a letter dated February 4, 2016, the Department informed Respondent that it was preparing to initiate an administrative action against her license because she had failed to submit a full set of fingerprints.
- 11. The Department's February 4, 2016 letter also informed Respondent that on or before March 4, 2016, she was required to submit the replacement set of fingerprints, or in the alternative, she could surrender her license.
- 12. Respondent did not submit a replacement set of fingerprints and she did not surrendered her license.
- 13. The Department requested that Respondent's license be revoked.

CONCLUSIONS OF LAW

- 1. The Department bears the burden of persuasion. ARIZ. REV. STAT. § 41-1092.07(G)(2).
- 2. The standard of proof on all issues is that of a preponderance of the evidence. Ariz. Admin. Code § R2-19-119.
- 3. A preponderance of the evidence is:

The greater weight of the evidence, not necessarily established by the greater number of witnesses testifying to a fact but by evidence that has the most convincing force; superior evidentiary weight that, though not sufficient to free the mind wholly from all reasonable doubt, is still sufficient to incline a fair and impartial mind to one side of the issue rather than the other. BLACK'S LAW DICTIONARY 1373 (10th ed. 2014).

- 4. With her application, Respondent was required to submit to the Department a complete set of fingerprints. Respondent's submission of fingerprints did not satisfy this requirement because the quality was not sufficient for DPS's use in conducting the required background check. See ARIZ. REV. STAT. § 20-285(E)(2).
- 5. Because Respondent did not submit fingerprints of sufficient quality, her application is incomplete, which is a violation of ARIZ. REV. STAT. section 20-295(A)(1).

6. Respondent's conduct constitutes a violation of ARIZ. REV. STAT., Title 20, which provides grounds for the Director of the Department to revoke Respondent's license. ARIZ. REV. STAT. § 20-295(A)(2).

RECOMMENDED ORDER

IT IS ORDERED that Respondent Jessica Marie Blatzheim's License No.

1122829 is revoked.

In the event of certification of the Administrative Law Judge Decision by the Director of the Office of Administrative Hearings, the effective date of the Order will be five days after the date of that certification.
