On April 29, 2016, the Arizona Department of Insurance ("Department") denied the license application submitted by Juan Pablo Cervantes ("Petitioner"). On May 16, 2016, Petitioner timely appealed the denial of his license application. The Department set a hearing on Petitioner's appeal at the Office of Administrative Hearings for July 5, 2016, at 1:00 p.m. in front of Administrative Law Judge Kay Abramsohn (the "ALJ").


On July 5, 2016, the hearing convened and Petitioner failed to appear.

On July 19, 2016, the ALJ filed an Order Vacating Hearing which vacated the scheduled hearing and remanded the matter to the Department. (Copy attached.)

The Interim Director of the Department of Insurance finds that Petitioner failed to appear for the hearing in this matter to demonstrate why he qualifies to hold the license.

The Interim Director Orders that the Department's April 29, 2016 denial of Petitioner's application for an insurance producer's license remains in effect.
