ORDER SUMMARILY SUSPENDING **BAIL BOND AGENT LICENSE AND** NOTICE OF OPPORTUNITY FOR HEARING

No. 16A-147-INS

The Arizona Department of Insurance (the "Department") alleges that Daniel James Wright has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Interim Director of Insurance for the State of Arizona ("Interim Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 1. Daniel James Wright ("Respondent") is licensed as a resident bail bond agent. Arizona license number 1089638, which expires on May 31, 2018.
- 2. Respondent's address of record is: 1235 W. Baseline Rd., #101, Tempe, AZ 85283 (business and mailing).
- 3. On March 22, 2016, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective as of April 21, 2016.
- On July 25, 2016, the Department notified Respondent that the surety holding 4. Respondent's bond had cancelled the bond effective April 21, 2016.
