ORDER SUMMARILY SUSPENDING BAIL BOND AGENT LICENSE AND NOTICE OF OPPORTUNITY FOR HEARING

The Arizona Department of Insurance (the "Department") alleges that **Timothy Edward Martin** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Interim Director of Insurance for the State of Arizona ("Interim Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- Timothy Edward Martin ("Respondent") is licensed as a resident bail bond agent,
 Arizona license number 1102288, which expires on December 31, 2018.
- Respondent's address of record is: c/o Dignity Bail Bonds, LLC, 1 East
 Washington, Suite 500, Phoenix, AZ 85004 (business and mailing).
- 3. On April 5, 2016, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective as of May 5, 2016.
- 4. On July 25, 2016, the Department notified Respondent that the surety holding Respondent's bond had cancelled the bond effective May 5, 2016.

NOTICE OF OPPORTUNITY FOR HEARING
