ORDER SUMMARILY SUSPENDING **BAIL BOND AGENT LICENSE AND** NOTICE OF OPPORTUNITY FOR **HEARING**

The Arizona Department of Insurance (the "Department") alleges that Katrina Monique Lopez has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Interim Director of Insurance for the State of Arizona ("Interim Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 1 Katrina Monique Lopez ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1129655, which expires on May 31, 2019.
- 2. Respondent's address of record is: c/o Dignity Bail Bonds, LLC, 1 E. Washington St., Suite 500, Phoenix, AZ 85004 (business and mailing).
- 3. On July 13, 2016, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective as of August 12, 2016.
- On July 25, 2016, the Department notified Respondent that the surety holding 4. Respondent's bond had cancelled the bond effective August 12, 2016.

To date, Respondent has failed to replace the cancelled surety bond.
