CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **JOANNE LYNNE SAVERCOOL** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT


1. Joanne Lynne Savercool, ("Respondent") is and was at all material times licensed as an adjuster, Arizona license number 1128598, which expires September 30, 2019.
2. Respondent's addresses of record with the Department are: c/o Gallagher Bassett Services Inc., 1215 Manor Dr., Ste. 101, Mechanicsburg, PA 17055-4917 (business), and 107 Lakewood Dr., Dingmans Ferry, PA 18328-4021 (mailing).
3. On or about October 21, 2015, the Department issued to Respondent a license as an adjuster, Arizona license number 1128598.
4. On or about August 8, 2016, the Department issued a Notice of Hearing In the Matter of Savercool, Joanne Lynne, No. 16A-061-INS ("Case No. 16A-061-INS").

1 **ORDER**

2 IT IS HEREBY ORDERED THAT:

3 Respondent shall pay the two hundred and fifty dollar (\$250.00) civil penalty assessed
4 in the prior Consent Order in Case No. 16A-061-INS and an additional civil penalty of two
5 hundred fifty dollars (\$250.00) is assessed for the violation of the Consent Order in Case No.
6 16A-061-INS. Both payments, totaling five hundred dollars (\$500.00), are due upon the
7 submission of this Consent Order. Payment shall be made to the Department in the form of a
8 certified check or money order.

- 15 1. Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law

22 waives her right to such notice and hearing and to any court appeals relating to this Consent
23 Order.

1 4. Respondent states that no promise of any kind or nature whatsoever, except as
2 expressly contained in this Consent Order, was made to her to induce her to enter into this
3 Consent Order and that she has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the
5 Director is solely to settle this matter against her and does not preclude any other agency,
6 officer, or subdivision of this state including the Department from instituting civil or criminal
7 proceedings as may be appropriate now or in the future not related to this matter.

8 6. Respondent acknowledges that this Consent Order is an administrative action
9 that the Department will report to the National Association of Insurance Commissioners
10 (NAIC). Respondent further acknowledges that she must report this administrative action to
11 any and all states in which she holds an insurance license and must disclose this
12 administrative action on any license application.


