**CONSENT ORDER**

**Respondent.**

The State of Arizona Department of Insurance ("Department") has received evidence that **Robert Stephen Buckshaw ("Respondent")** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Respondent is, and was at all material times, licensed as an Arizona resident accident/health, life, property and casualty insurance producer, Arizona license number 871738, which expires on December 31, 2017. Respondent first became licensed with the Department on August 16, 2006.

2. Respondent's address of record is: 3813 W. Commonwealth Ave., Chandler, AZ 85226-5037 (business and mailing).

**FAILURE TO NOTIFY**

3. On or about December 16, 2015, in the Superior Court of Arizona, Maricopa County ("Court"), the Court held an Initial Pretrial Conference in State of Arizona v. Robert Stephen Buckshaw, CR2015-148482.

1 4. Respondent failed to notify the Department of the criminal prosecution in writing  
2 within thirty days of the initial pretrial hearing date.

3 **CONCLUSIONS OF LAW**

4 1. The Interim Director has jurisdiction over this matter.

5 2. The Interim Director may accept the voluntary surrender of a person's license,  
6 within the meaning of A.R.S. § 20-289(F).

7 3. Respondent's conduct, as described above, constitutes failing to notify the  
8 director of any criminal prosecution of the producer taken in any jurisdiction within thirty days  
9 after the initial pretrial hearing date, within the meaning of A.R.S. § 20-301(B).

10 3. Respondent's conduct, as described above, constitutes violating any provision of  
11 Title 20, or any rule, subpoena or order of the director, within the meaning of A.R.S. § 20-  
12 295(A)(2).


13 4. Grounds exist for the Interim Director to deny, suspend for not more than twelve  
14 months, revoke, or refuse to renew an insurance producer's license pursuant to A.R.S. § 20-  
15 295(A).

16 **ORDER**

17 IT IS HEREBY ORDERED THAT:

18 1. Respondent may surrender his resident insurance producer license, Arizona  
19 license number **871738**.

2           1.     Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law

4           2.     Respondent admits the jurisdiction of the Director of Insurance, State of Arizona,  
5 and admits the foregoing Findings of Fact and consents to the entry of the foregoing  
6 Conclusions of Law and Order.

7           3.     Respondent is aware of his right to notice and a hearing at which he may be  
8 represented by counsel, present evidence and examine witnesses. Respondent irrevocably  
9 waives his right to such notice and hearing and to any court appeals relating to this Consent  
10 Order.

11           4.     Respondent states that no promise of any kind or nature whatsoever, except as  
12 expressly contained in this Consent Order, was made to him to induce him to enter into this  
13 Consent Order and that he has entered into this Consent Order voluntarily.

14           5.     Respondent acknowledges that the acceptance of this Consent Order by the  
15 Director is solely to settle this matter against him and does not preclude any other agency,  
16 including the Department, officer, or subdivision of this state or this agency from instituting civil  
17 or criminal proceedings as may be appropriate now or in the future.

18           6.     Respondent acknowledges that this Consent Order is an administrative action  
19 the Department will report to the National Association of Insurance Commissioners (NAIC).

20 Respondent further acknowledges that he must report this administrative action to

1 any and all states in which he holds an insurance license and must disclose this administrative  
2 action on any license application.

3 7. Respondent acknowledges that a person who surrenders a license shall not  
4 reapply for the same license for at least one year after the date of the surrender.


