CONCLUSIONS OF LAW

- 1. The Interim Director has jurisdiction.
- 2. Respondents' conduct constitutes compliance with the requirement that each bail bond agent maintain in force while licensed a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

<u>ORDER</u>

IT IS HEREBY ORDERED THAT:

- 1. With the submission of the statutorily required surety bond, the Department shall reactivate Hemerlein's bail bond agent license class as of the filing date of this Order Reinstating Bail Bond Agent License Class.
- 2. With the submission of the statutorily required surety bond, the Department shall reactivate Hemerlein Holdings' bail bond agent license class as of the filing date of this Order Reinstating Bail Bond Agent License Class.
