In light of the serious nature of these 13 allegations, the Interim Director of Insurance for the State of Arizona ("Director") finds that the 14 public health, safety and welfare imperatively require emergency action, within the meaning of 15 A.R.S. §41-1092.11(B). 16 **FINDINGS OF FACT** 17 Peter John Hemerlein ("Hemerlein") is licensed as a resident property and 1. 18 casualty insurance producer and bail bond agent, Arizona license number 1125279, which 19 expires on January 31, 2019. 20 Respondent's address of record is: 10434 N. 42nd Pl, Phoenix, AZ 85028 2. 21 (business and mailing). 22 23

STATE OF ARIZONA

- Hemerlein Holdings, LLC ("Hemerlein Holdings") is licensed as a resident property and casualty insurance producer and bail bond agent, Arizona license number 1129575, which expires on October 31, 2019.
- 4. Hemerlein Holdings' address of record is: 10434 N. 42nd PI, Phoenix, AZ 85028 (business and mailing).
- Hemerlein is the Owner and Designated Responsible Licensed Producer of Hemerlein Holdings.

LAPSE OF HEMERLEIN SURETY BOND

- 6. On October 17, 2016, the insurer holding Hemerlein's surety bond notified the Department that Hemerlein's bail agent bond was to be cancelled, effective November 28, 2016.
- 7. On October 24, 2016, the Department notified Hemerlein that the surety was cancelling his bond.
 - 8. To date, Hemerlein has failed to replace the cancelled surety bond.
- 9. Therefore, as of November 28, 2016, Hemerlein has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

LAPSE OF HEMERLEIN HOLDINGS SURETY BOND

- 10. On October 17, 2016, the insurer holding Hemerlein Holding's surety bond notified the Department that Hemerlein Holding's bail agent bond was to be cancelled, effective November 28, 2016.
- 11. On October 24, 2016, the Department notified Hemerlein Holdings that the surety was cancelling its bond.
 - 12. To date, Hemerlein Holdings has failed to replace the cancelled surety bond.

- 13. Therefore, as of November 28, 2016, Hemerlein Holdings has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
 - 14. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondents' conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- Grounds exist to order a summary suspension within the meaning of A.R.S. §
 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

- Hemerlein's bail bond agent line of authority under Arizona license number
 1125279 is summarily suspended effective immediately.
- Hemerlein Holding's bail bond agent line of authority under Arizona license number 1129575 is summarily suspended effective immediately.
- Hemerlein's property and casualty insurance producer lines of authority under
 Arizona license number 1125279 are not suspended.
- 4. Hemerlein Holding's property and casualty insurance producer lines of authority under Arizona license number 1129575 are not suspended.
