ORDER SUMMARILY SUSPENDING BAIL BOND AGENT LICENSE AND NOTICE OF OPPORTUNITY FOR HEARING

The Arizona Department of Insurance (the "Department") alleges that **Stella Paola Valdez** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Interim Director of Insurance for the State of Arizona ("Interim Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- Stella Paola Valdez ("Respondent") is licensed as a resident bail bond agent,
 Arizona license number 1076479, which expires on April 30, 2018.
- 2. Respondent's address of record is: 1837 S. Mesa Dr., Ste A200, Mesa, Arizona 85210-6219 (business and mailing).
- 3. On October 24, 2016, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective as of November 23, 2016.
- 4. On October 31, 2016, the Department notified Respondent that the surety was cancelling her bond.
