The 16 Department issued Arizmendi a license effective March 13, 2015. ## Falsification of Insurance Claims

- 4. Arizmendi falsified an insurance claim related to an automobile accident involving three (3) vehicles which occurred on or about March 9, 2016. Falsification of the claim occurred when Arizmendi added the name of Daniel Flores ("Flores") as a "claimant driver" involved in the accident. A police report taken at the time of the accident identified all drivers and passengers of the subject vehicles. Flores was neither a driver nor passenger in any of the vehicles.
- 5. Sentry Insurance, A Mutual Company ("Sentry"), employed Arizmendi at the time of the March 9, 2016 accident.
- 6. On January 18, 2017, as a result of the falsified claim, Sentry issued a check to Flores in the amount of \$25,000.00.
- 7. Arizmendi falsified an insurance claim related to an automobile accident involving two (2) vehicles which occurred on or about May 12, 2016. Falsification of the claim occurred when Arizmendi added the name of his sister, Janet Trejo, to the claim. Trejo was neither of the identified claimants involved in the accident.
  - 8. Sentry employed Arizmendi at the time of the May 12, 2016 accident.
- 9. As a result of the falsified claim, Trejo received \$4,489.00 in insurance proceeds from Sentry for alleged property damage and bodily injury,
- 10. On March 8, 2017, Sentry interviewed Arizmendi who admitted to falsifying both claims.

## Failure to Notify - Address Changes

11. On or about March 8, 2017, Sentry terminated Arizmendi's employment. Until his termination, Arizmendi used Sentry's physical address (Via Linda) as his mailing address of

record which is no longer valid. Arizmendi failed to timely notify the Department of a change in mailing address.

12. On or about April 20, 2017, Department staff attempted to personally contact Arizmendi at his business address of record (Bowker Street). The person who responded to Department staff identified himself as Arizmendi's father and he stated that Arizmendi had moved out four (4) months earlier and he claimed not to know where his son currently lives. Arizmendi's business address is no longer valid. Arizmendi failed to timely notify the Department of a change of business address.

## **CONCLUSIONS OF LAW**

- 1. The Interim Director ("Director") has jurisdiction over this matter.
- 2. Respondent's conduct, as described above, constitutes a violation of Title 20, within the meaning of A.R.S. § 20-295(A)(2).
- 3. Respondents' conduct, as described above, constitutes using fraudulent and dishonest practices, and demonstrating incompetence, untrustworthiness and financial irresponsibility in the conduct of business in this state or elsewhere, within the meaning of A.R.S. § 20-295(A)(8).
- 4. Respondents' conduct, as described above, constitutes presenting, causing to be presented or preparing with the knowledge or belief that it will be presented, an oral or written statement, including computer-generated documents, to an insurer that contains untrue statements of material fact or that fails to state any material fact with respect to a claim for payment or benefit pursuant to an insurance policy or payments made pursuant to the terms of an insurance policy, within the meaning of A.R.S. § 20-463(A)(1)(c) and (e).

waives his right to such notice and hearing and to any court appeals relating to this Consent Order.

- 4. Respondent states that no promise of any kind or nature whatsoever, except as expressly contained in this Consent Order, was made to him to induce him to enter into this Consent Order and that he has entered into this Consent Order voluntarily.
- 5. Respondent acknowledges that the acceptance of this Consent Order by the Director is solely to settle this matter against him and does not preclude any other agency, officer, or subdivision of this state including the Department from instituting civil or criminal proceedings as may be appropriate now or in the future.
- 6. Respondent acknowledges that this Consent Order is an administrative action the Department will report to the National Association of Insurance Commissioners ("NAIC") and that he may have to report this administrative action on any future licensing applications either to the Department or other states' Departments of Insurance.
