- 1. Kanawha Insurance Company ("Petitioner") is a Texas domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective March 3, 1989.
- 2. Effective August 9, 2018, Petitioner, the non-surviving entity, merged into Continental General Insurance Company (CGIC), NAIC No. 71404, a Texas domiciled insurer and the surviving entity. CGIC is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- The Insurance Commissioner of Texas approved the merger of Petitioner into
   CGIC on July 31, 2018.
- 4. Petitioner has no outstanding obligations under any policy of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants who are residents of this State.
